Exhibitor/owner release Carbon County 4H (including Carbon County 4H officers, directors, employees, volunteers and members) and Yellowstone Dog Sports, and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises.
